This License Agreement does not grant you any rights in connection with any trademarks or service marks of Scaffolding Software or any other entity whose software or content you may access through use of the Product.

### **Agreement**

This Software License Agreement is a legal agreement between you the client, a duly registered company or an individual, who will be referred to in this License Agreement as “You” and Caysa Pty Ltd acting as trustee for Caysa Technologies Trust trading as “Scaffolding Software” a duly registered company in Australia whose principal place of business is 2203/265 Exhibition Street, Melbourne, Australia who will be referred to in this License Agreement as “Scaffolding Software”.

Software is defined as the sContract, iScaf, iRent, iRent ERP, iQuote Software computer programs with which this Software License Agreement is included and any updates or maintenance releases thereto.

### **Terms and Conditions for Quotation or Sale**

Quotations and invoices that you receive from Scaffolding Software are subject to Copyright and with the exception of government audits, no part of the quotation or invoice may be reproduced, transferred, sold or otherwise disposed of, without the written permission of Scaffolding Software.

You retain ownership of the quotation documents. However, the methodology or format used to derive the quotation is confidential to Scaffolding Software. These documents must be treated as confidential. They can be used and copied within your organisation, however, the documents, including copies of it, must not be disclosed to any person who is not a director, officer, employee of the customer without the prior written approval.

Prices are subject to change. Unless specified, quotations are valid for 30 days.

### **Licenses**

Scaffolding Software Licenses can be NON Subscription (Perpetual) or Subscription licenses. Upon receipt of payment for NON Subscription licenses in accordance to the Invoice from Scaffolding Software, you are granted a non-exclusive License to use sContract, iScaf®, iRent®, iRent® ERP, iQuote® separately limited by a number of users on a network and/or install it on a limited number of workstations. The number of users and workstations the License is limited to, is specified on the Invoice or Quotation. Licensee may at any time request from Scaffolding Software an offer for a license for additional users and/or workstations.

Failure to pay invoices to Scaffolding Software for software licenses of software subscriptions can result in the de-activation of the Software or suspension of cloud services and Software.

Upon receipt of payment for Subscription licenses, you are granted the same use of the licenses but only for the period of time as specified on the subscription invoice. The date for the start of software support or the start of a subscription is the date the software is installed on the server or workstation. For the iScaf® software, Effective March 1, 2019, if you have a subscription or full license with an active ASU, you are permitted to install each license on two workstations for single use at a time.

### **License Control**

You acknowledge that the Software may contain code or require activation keys that may detect or prevent unauthorized use of, or disable, the Software. For subscriptions, the software will contain an expiry date which can be extended when subscriptions are renewed.

### **Copyright**
